Terms:

The contracted party agrees to the above listed services and any other services agreed upon by both parties. A \$100 non-refundable deposit and signed contract is required before consultation or trial run and in order to reserve the wedding date. The amount is due in full on the day of services for the 2nd and 3rd sessions of bridal hair and makeup. The balance of the wedding day services for the bride are due at the wedding. For all additional wedding day services, 50% is due 30 days before and the balance of the cost of the additional services (50%) is due on the wedding day/day of services. There are absolutely no refunds. Once contract is signed, the amount due cannot be decreased and is due in full regardless of any cancellation, with no exceptions. Weather related wedding re-scheduling will be done at no extra charge. YBF will give the customer a timeline for the day of services. If customers are late on the service date according to the timeline, it is not guaranteed that we can complete the services listed above in the original time frame, however the balance will be due in full regardless of services rendered. The artists will provide services in the timeline rendered and if customer requests artists to stay past the timeline, \$1/minute/artist will be charged in overtime. A \$50 no show fee will be added if customer fails to give more than 24 hour notice of rescheduling of any appointment including consultations and trial runs. Your Beautiful Face (YBF) representatives reserve the right to add any additional fees to the contract amount based on changed travel, starting times, long/thick hair, extra coverage requests, and the need of an assistant with prior notice given to customer. A credit card must be given upon signed contract and is understood that it can be charged for any cancellations or additional fees that are not paid by the time the service is rendered. Time slots are issued on a first come, first serve basis. We do not guarantee being able to accommodate a time/place change after contract is signed. The representative, nor YBF, nor BeautiControl is not responsible

for any customer reactions to products used nor for any reasonable techniques in rendering services. All services are at the permission of the client at his or her own risk. The service provider reserves the right to terminate any service at any time if subjected to abusive, offensive, extreme or dangerous behavior by any customer(s) in which case contract payments will still be due in full even if services are not rendered. Any work above performed under this contract is intellectual property of YBF and not of the individual artist(s) working for YBF . Any photos or representation of the hair and makeup artistry will only be used to advertise YBF and not that of any other hair/makeup/beauty company. At no time will above said customer allow any other individual or contracted employee to represent the work as that of another company or of the individual artist. All prices listed are for cash/check/MO customers only. A convenience fee will be charged based on the total amount charged for using a credit card except when paying the \$100 deposit. A \$25 fee will be charged for any returned checks. Sorry no post dated checks allowed. If payments are not received after 3 attempts to collect, we reserve the right to cancel services.
